





- 2) No, absolutely not. Professor Derengowski made it clear from day one that he came from a Christian world view. However he taught each class, based on the TCC-approved syllabus, fairly and historically. There were no surprises in this class...everyone had the syllabus and knew what subject were coming up when. And in the rare occasions a student did disagree, Professor Derengowski allowed collegiate debate so that we could all learn.
- 3) Yes. I'd like to add that this entire situation is very sad, on so many levels. At the end of the day, I feel like TCC administration dropped the ball by being unavailable, unresponsive to the other students in the class, and responded with a knee-jerk reaction that has impacted everyone involved. This last semester was a terrible one, and based on TCC's actions, I find myself reevaluating my long-term educational goals and where I want to accomplish them. Professor Derengowski is an amazing Professor....I learned so much from him. Dean Munoz should've given some cooling off time and talked to Professor Derengowski afterward he shouldn't be out of a job. And Professor Mark Austin....it was uncomfortable for him and the students to be thrust in the situation. And Sharon Wettengel....she was put in an impossible position. At the end of the day, Professor Derengowski's syllabus, along with the references to his personal web site, was approved by TCC administrators. At least, according to Sharon Wettengel it was.

I'm not defending Derengowski or trying to slander his name. I just want someone to understand the truth. If this goes on deaf ears and blind eyes well at least I can say I tried.

While in Prof D's class I never felt threatened, discriminated, or belittled based on my beliefs. I'm not a Christian, Muslim, Jew or any of the other major religions he covered. He talked about my belief system, and told what it was a his thoughts about it. I didn't agree with what he said but I didn't flip out on him.

the night of the incident(s) went like this: He asked us all what we thought about when the words "Islam" and "Muslim" were brought to our attention. There was an awkward silence and people began to list off what they thought. None thich were Terrorism, Jihad or the like. He began to talk about Muhammad's life and his upbringing and his early careers and stuff of the sort. Well when we slowly but surely got to the section where we were talking about funding his religion, the Muslim students became irate and unruly. Derengowski handled it in an appropriate, calm and professional manner and when his credibility was called into question, he told the students he would bring in his sources so that he would make it clear. The next class we started by him reading his sources and the Muslim students wouldn't have it. They told him his degree was worthless, that he had no clue what he was talking about, and basically slandered him in front of all of us. I personally thought it was uncalled for. If you have a problem with a teacher you should approach them after class. Well after they would stop arguing, he tried to move on and the Muslim students kept asking questions like "Why is this the main focus? It feels like this is all you're talking about." I talked to my fellow classmates and we all agreed there was no focus on this, but more that our Islamic equals just wouldn't let it go. Nothing in his lecture was malicious or insulting.

I will provide answers to the questions you have sent to me; however; I will in no shape or form take part in the witch hunt that has been enacted against Mr. Derengowski. While I do no agree with the statements made on his personal webpages; it should be said that those comments were never brought into the class room. My disappointment lies with the Administration of TCC and how this situation was handled. You took the word of two people who were threatening and brought about a hostile enviornment in the classroom when Christianity and the Muslim faith were discussed (direct information read for the Quarn mind you.) and never at any time consulted with the rest of the student body of this class. The situation was handled poorly in my opinion. Hello, Mr. Coronado.

and I was one of the students that was not only in Mr. Derengowski's class this last semester, but was also in class the night of the argument over Islam. Now, to proceed to your questions:

- 1.) No, I never felt threatened during Mr. Derengowski's class. He might have been very passionate about his subject, (which, in my opinion, is an attractive quality in a professor; I didn't pay for a semester of indifference) but he never made me feel uncomfortable. Mr. Derengowski is a courteous man who never spoke ill of any religion other than his own during his class. He might have had his opinions outside of the classroom -which he's entitled to-, but he never voiced them openly in class.
- 3.) Yes, there are a few comments I would like to make. At first I, too, felt uncomfortable about the articles I was sent supposedly written by Mr. Derengowski. However, as I've had time to deliberate the situation, I've come to one conclusion: Mr. Derengowski is entitled to any opinions or affiliations outside of the classroom. He NEVER brought those ideas into the classroom, he never tried to convert anyone, and he never openly voiced any 'intolerance' towards anyone's belief. He might have it, of course, but he never voiced it. Everyone has their own opinions. He's a conservative man...and I feel that conservatives are the ones who are discriminated against the most in modern day society. A psychology teacher can openly say in class that homosexuality is acceptable because you cannot choose your sexual preference...and THAT'S okay. I say it because I experienced it. Liberal ideology and opinion is condoned; any efforts to muffle it is called discrimination. However, when a conservative has an opinion, their beliefs themselves are prejudice. 

Your complaint was quite thorough, and you've even included copies of previous discussions with other campus personnel, related to the issue.

In your written complaint you make three distinct accusations:

- 1. The students and will and violated student handbook policy by continually disturbing class.
- 2. That Ms. defamed Professor Derengowski with an email to the class.
- 3. (Though not mentioned on the complaint form), by copy of emails, an indication that you were concerned for your safety, specifically because of a statement you accuse making, when you accuse him of stating to the class, "you should be scared."

You also clarify that the outcome you hope to achieve specifically, is:

"That TCC will adhere to their policies setforth in thr Student Handbook on the issues I've addressed."

To consider this matter, I am working with the academic administrators involved, the campus police, and district administration. We are reviewing any/all records of disruptions in the class if any exist, reported by anyone including instructor and/or students. I am working with our Title IX Coordinator and HR personnel to refer the accusation of defamation for their investigation. And though listed last here and not part of your formal complaint, my first actions were to explore the safety issue, eginning by working directly with the police that were involved that night, then reviewing records or eports related, to include any reports of concerns made by instructor or students, if any. If you sense that I have not read your statements correctly, and that a discussion in person would help to clarify matters, I am willing to schedule an appointment to speak with you, if you like. Is there something you wish to discuss, that was not covered in your written complaint?

As I stated on the complaint form, the complaint box wasn't big enough to hold the information and the emails were attached.


Item 1 – Student 19, attached to the complaint from – the 3rd paragraph states "I also stated in my original email the continual, disruptive, behavior displayed by 19, even after Professor D spoke with him and had to stop class numerous times each class. Page 41 of the Student Handbook addresses this situation. Dean Coan and Dean Munoz were both made aware of this - I'm confused why this student is still allowed to attend the class and the fact this student secretly taped the class. This was pointed out at the beginning of the semester recording the class was not allowed per the Student Handbook.

Item 2 – A copy of the email sent to the entire class was attached to the complaint form.

Item 3 - Also stated in the email dated November 19th, sent to Professor Whettengel, the 2nd paragraph states "my safety was of concern after the class was threatened by stating you should be scared". My concern has yet to be addressed by TCC administration. Professor D filed a police report with the Campus Police in regards, not only for his safety, but for the safety of his students. I have been discriminated against. Had I been one of the Muslim students would the

concern for my safety been addressed? In the Student Handbook under Illegal and or disruptive behavior, Item # 4 addresses students being threatened. "

As you may be aware – I was interviewed by the editor of The Collegian. After reading the second article on Professor D – I sent an email to containing the lies stated by and in the article (included below):



I read the newest article on Professor Derengowski last night. The Collegian has done the best job reporting the information. However, I was a little irritated with the information given by the Muslim students.

- 1. The first lie in the article "A lot of people said 'terrorist,' and '9/11' and all that," she said.?

 One mention was made of the American hostages Iran took in 1979 and no one said 9/11. There were may have been five comments made I don't consider that "a lot".
- 2. "We did not threaten the teacher, nor did we cause any disruption," she said. "We were rightfully debating the information he was giving." Really then why did the male Muslim student say "You should be scared" as he abruptly left the classroom. And if no disruption were created why did half the class stay afterwards to discuss the disruption?
- 3. Another lie told by the female Muslim student "Do employers not research people's personal Facebook pages when looking to hire them? Did TCC not do the same with a professor who is trusted to touch such sensitive subjects with a proper and respective manner?" Professor Whettengel stated the night she addressed the class that "yes a background check was done on Professor Derengowski".
- 4. Another lie told by the female student Derengowski didn't use the textbook to make the Islam lesson, the female Muslim student said. I have information highlighted in the text book Professor D gave us during the class as well as notes he gave us on the history of the book.

The professor that took over the class has stated "this textbook is biased". Thanks for letting me share this information with you.

As you stated below - this information was sent to Dean Munoz and Dean Coan – copies of those emails dated November 17, were also attached to the complaint form. I know other students in the class have completed and submitted complaints to you as well regarding this situation. I will be at TCC Tuesday at 5:30 taking the final for Professor D's class. I can meet with you after that.

1. Did you feel threatened at any time during Mr. Derengowski's class? If so, please explain, including specific actions and comments which caused you to feel threatened.

Yes, I never experienced in my entire life as an ESL student to see and hear someone threatening a teacher in class only in Prof. Derengowski class, it's something new for me and it's traumatizing. Our class has been terrorized. To be honest and acted like a radical Islam. All religion has flaws and past history of violence no religion is exempted from this.

On the night of Nov. 8 were going over the history and life of Prophet Mohammed.

humiliated Prof. D in class after he read/quoted some scripture from Quran and his other reference. He raised his voice, slam his table a few times, and worse of all he demean Prof. D's educational background according to him he's not qualified to teach his religion because Prof. D was ignorant about Islam. I felt sorry for Prof. D; showed no respect at all to his teacher and classmates while he's at TCC campus.

and emphasize in class that Prof. D was taking everything out of context from Quran and he was falsely teaching Islam. And said to Prof. D "do you think we will just sit here without saying anything. Why are we talking about this? Why not focus on the good things about Islam." They never let Prof D finish his sentence without constant interruption how rude! And before left the class he said to Prof. D he should be careful they left together and slam the door.

When Prof. D didn't show up for the next class after the mock trial Dean Munoz took our attendance for that evening I saw and giving each other a high five and smiling from ear to ear a little celebration from their end; while the rest of the class were wondering what's going on.
